

ASSUMPTION OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

In consideration of, and as a precondition to my purchase of a ticket to and physically attending a Life Event (Event), I understand and agree to all of the terms and conditions set forth below.

1. Assumption of Risk. I understand and am aware of the highly contagious nature of bacterial and viral diseases, including but not limited to, the 2019 novel coronavirus disease and its variants ("COVID-19"). I understand and assume the risk that I may be exposed to others with COVID-19 and could contract COVID-19 as a result of my attendance at the Event Venue and my participation in Event activities. I acknowledge that I could be exposed to COVID-19 in any public place and that there is no way to guarantee my protection from such exposure. I understand and assume the risk that my possible exposure and infection could result in my personal illness, injury, pain, suffering, temporary or permanent disability, death, property damages, or financial loss. I understand that while Life and the Event Venue have implemented preventative measures designed to reduce the spread of COVID-19, Life cannot guarantee that I will not become infected with COVID-19 (or other infectious diseases) while I am in the Event Venue or engaging in Event activities. I acknowledge and agree that, despite the risks associated with COVID-19 or other infection diseases, I am choosing to voluntarily enter the Event Venue and engage in Event activities with full knowledge of the potential danger involved. I hereby agree to accept and assume all risks of illness, personal injury, psychological injury, pain, suffering, disability, death, property damage, or financial loss related to COVID-19 or other infection diseases, arising from my presence in the Event Venue or participation in Event activities, whether caused by the actions, negligence or omissions of Life and its representatives or other third parties.

2. Release of All Claims. I hereby expressly waive and release any and all claims, now known or hereafter known, against Life, and its affiliated companies and any of their officers, employees or agents (collectively referred to as "Releasees"), on account of injury, illness, disability, death, property damage, or financial loss which may arise out of my presence in the Event Venue, or my engaging in Event activities. I irrevocably promise not to sue Releasees, and agree not to make or bring any other claims against Releasees, arising out of my exposure to or contraction of COVID-19 (or other infectious disease) or any other injury or damages I may experience by virtue of my presence in the Event Venue or my participation in Event activities.

3. Agreement to Follow All Infectious Disease Guidelines. I agree to comply with all federal, state and local orders, directives, and guidelines related to COVID-19 and other infectious diseases while in the Event Venue or participating in Event activities. I will also follow all instructions of Life while in the Event Venue and participating in Event activities. I agree not to enter the Event Venue or participate in Event activities if: (i) I am experiencing symptoms of COVID-19 (such as cough, shortness of breath, or fever, etc.), (ii) I have tested positive for COVID-19 within the previous fourteen (14) days, or (iii) I have recently been exposed to someone with a confirmed positive test for COVID-19 or who is experiencing symptoms of COVID-19 within the ten (10) days prior to the Event.

4. Indemnification. I agree to defend, indemnify, and hold harmless Releasees against all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including, but not limited to, actual attorney fees incurred, the cost of enforcing any right to indemnification under this Release, the

cost of pursuing any insurance providers, the cost of defending against claims pursued against any Releasee, related to my contraction of COVID-19 (or other infectious disease) due to my attendance at the Event Venue or my participation in Event activities.

5. Binding Agreement. This Agreement constitutes the sole and entire agreement between Life and myself with respect to the subject matter and supersedes all prior understandings, agreements, and representations covered in this Agreement. If any term or provision of this Release is deemed invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. This Agreement is binding on and shall inure to the benefit of Life and me and our respective successors and assigns. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the internal laws of the State of North Carolina without giving effect to any choice or conflict of law provision or rule (whether of the State of North Carolina or any other jurisdiction). Any claim or cause of action arising under this Agreement may be brought only in the federal and state courts located in Wake County, North Carolina and I hereby consent to the exclusive jurisdiction of such courts.

I HAVE READ THIS ASSUMPTION OF RISK, ND RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND FULLY UNDERSTAND ITS TERMS. I FURTHER UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW. I UNDERSTAND AND AGREE THAT MY SIGNING OF THIS AGREEMENT IS AN ABSOLUTE PRECONDITION TO MY ACCESS TO THE EVENT VENUE AND PARTICIPATION IN EVENT ACTIVITIES.
